Europe-ATP holds inaugural meeting in London/

Elects officers

The new European Division of ATP held its inaugural meeting September, 28, in London, England. Twenty five delegates, representing 21 organizations and nine countries attended the meeting which was hosted by Pearson VUE. ATP Board Member Marten Roorda of Cito, chaired the meeting.

"The delegates split up in four different sectional groups: certification, educational, occupational and psychological/clinical in order to determine the right focus for activities of the European Division...for all sections there was much found in common regarding the public image of testing, intellectual property, and test security," Roorda reported.

He said that among the goals that were decided upon for the coming year were: Enact a founding membership discount for new E-ATP members in 2007; Form working groups to construct a website and organize an event in September 2007; Initiate membership development with some of the CEOs of larger test publishers; Set up contacts with affiliated organizations, and to initiate the adoption of quality standards from other organizations.



Historic London, England was the site of the inaugural meeting of ATP's new European Division.

Following the meeting three new officers were elected to lead the new division. They are Eric Shepherd, of Questionmark, as Chair, Dr. Cor Sluijter, of Cito, as Vice Chair and Paul Howarth, of VUE UK, as Secretary.

It has been a busy fall for Education in ATP. Because of your own busy schedule you probably haven't noticed. Let me bring you up to date.

Operational Best Practices for Large Scale Assessments

As reported in our Summer Newsletter, ATP has held preliminary discussions about establishing a Best Practices document for the operational aspects of Large Scale Assessments (e.g., printing, distribution, scanning, scoring and reporting). If the testing community and the states and large districts who purchase our services and products can agree on a set of voluntary, non-binding best practices, it has the potential to bring greater uniformity to the requirements in RFP documents and greater quality assurance to the operational implementation of large scale programs. Testing contractors will be able to deliver high quality more consistently, and states and large districts will see fewer errors and delays.

In the meantime, ATP has heard from several assessment companies and organizations who wish to discuss and learn more about the goals of this initiative with the states and large districts. To accommodate this request, ATP held a general meeting for representatives of all interest-

ed assessment companies who are members of either ATP or the AAP Test Committee. The meeting was held in Washington, D.C. on December 5, 2006 at the AAP headquarters located at 50 F Street, NW. All ATP member companies were invited to attend this meeting.

John Oswald, Senior Vice
President/General Manager of the

Division of ETS chaired the meeting, and
G Harris, ATP's Executive Director, Alan
Thiemann, ATP's legislative counsel, and
I attended to help respond to questions
and suggestions from those present. We
had a large turnout and expect positive
outcomes from the meeting which I will
report on at a later date.

From the Desk of the Industrial/Organizational Division

Chair...Dr. David Waldschmidt of Wonderlic Inc.

The test publishing industry has undergone dramatic changes in recent years. Mergers and acquisitions have occurred with great frequency, the legal environment has grown in complexity due to legislation such as Sarbanes-Oxley, and technological advances have resulted in sweeping changes to the way tests are commonly administered, scored, and reported. We can be assured that the future will bring additional change due to the recent shift in power in Washington, the trend towards outsourcing, and the globalization of the test publishing industry. How should test publishers respond to this ever-changing landscape? What should the role of ATP be as we face this uncertainty? How should the I/O division evolve in order to capitalize on these changes and move the test industry forward?

I believe that the answer lies in our ability to together transform ATP to become an organization that is a bit more proactive and focuses on changing the image that some of the public has towards testing. I firmly believe that testing represents the most fair and objective means of establishing an individual's qualifications for employment. High quality assessments that are valid, reliable, and free from bias provide employers with invaluable information for making employment decisions. 2007 award winners to be honored at conference

Dr. Frank Schmidt will receive the 2007 Career Achievement Award and Dr. John Fremer will be the first-time recipient of a new award this year -- the Award for Professional Contributions and Service to Testing.

Frank Schmidt, Ph.D. is the Ralph L. Sheets Professor of Human Resources in the Tippie College of Business at the University of Iowa. In the last three decades Dr. Schmidt has authored over 150 refereed journal articles, 5 books, 40 technical reports, 10 reviews, and 250 conference presentations. Frank Schmidt's works in the area of meta-analysis have demonstrated clearly the distorting influence of statistical artifacts in making inferences from observed correlations. He has provided a framework for assessing validity



generalization and has revolutionized the testing industry. The majority of his papers have been on meta-analytic techniques, applications of meta-analysis, as well as on measurement and reliability issues. His book 1990 Methods of Meta-Analysis (with Jack Hunter) is the standard for anyone conducting a meta-analysis in many fields, including but not limited to management, psychology, sociology, anthropology and even medical sciences. Dr. Frank Schmidt, who holds a doctorate in Industrial/Organizational Psychology from Purdue University has been honored by the American Psychological Association (APA) and the Society of Human Resource Management (SHRM).

John Fremer, Ph.D. has 40 years of experience in the field of test publishing and test program development and revision, including management level positions at Educational Testing Service and The Psychological

Corporation/Harcourt. Currently, John is founder and Sr. Director of Caveon Test Security.

In his 35-year career at Educational Testing Service, Fremer led the ETS team that worked with the College Board to develop the current version of the SAT. Fremer is a Past President of



the National Council on Measurement in Education (NCME) and a former editor of the NCME journal Educational Measurement: Issues and Practice. Fremer also served as President of the Association of Test Publishers (ATP) and the Association for Assessment in Counseling (AAC). He was co-chair of the Joint Committee on Testing Practices (JCTP) and of the JCTP work group that developed the testing-industry-wide Code of Fair Testing Practices in Education; one of the most frequently cited documents in the field of educational measurement. Fremer is a co-editor of Computer-Based Testing: Building the Foundations for Future Assessments, (2002, Erlbaum.)

Eric Shepherd, CEO of Questionmark, to lead ATP's new European Division

This fall the European Division of ATP (E-ATP) held its first election of officers. As a result, Eric Shepherd, CEO of Questionmark, will serve as the chair of the new division.



As CEO of Questionmark, Shepherd leads the organization in producing groundbreaking software for authoring, delivering and reporting on tests and assessments.

In addition to his work with Questionmark, Shepherd has been instrumental in the development of the IMS Learning Consortium's Question and Test Interoperability standard, embraced by assessment professionals worldwide as a practical means of moving questions from one system to another. Shepherd has advised corporations, government departments, universities, schools and technical standards bodies on the deployment of computerized assessments. In addition, Shepherd conducts seminars and workshops around the world on secure assessment technology.

Shepherd has addressed gatherings of the Association of Test Publishers, American Society for Training & Development (ASTD), e-Learn Expo (Paris and Moscow), Online Educa (Berlin), TechLearn, International Society for Performance Improvement (ISPI), League for Innovation, the Computer Aided Assessment Conference (CAA), eLearning Brasil, and many other organizations.

Q & A with Eric Shepherd

Q: What kinds of contributions do you think the European Division of ATP will be able to make to the European test publishing community?

A: By providing a pan European voice for test publishers we can provide a consistent message that will assist consumers, unions, and law makers in understanding the benefits of testing. Promoting understanding and reducing confusion will also aid the stakeholders to distinguish the true value of tests.

Q: What are the challenges facing the European test publishing community today?

A; The fragmented nature of the test publishers throughout EU means that it is difficult to represent a productive and consistent message which could possibly lead to inappropriate legislation or resistance to the potential benefits of testing. By enabling a consistent message, whilst considering

the legal and cultural differences, E-ATP will be able to provide a forum for leaders and law makers to reach agreements that will benefit all Europeans.

Q: Why ATP? What is it about ATP as an organization that you believe makes it worthy of extending its reach Internationally and specifically into Europe at this time?

A: With ATP's increasing membership of stakeholders that develop, deliver and consume tests throughout Europe it was an easy and natural development for ATP to create a forum for discussion and an organizational structure to create possibilities for the future.

Q: Conversely, how can the European Test Publishing community contribute to ATP?

A: European Test Publishers can contribute to the E-ATP's efforts by getting

involved and being part of the creation process. By attending meetings and being part of the discussion test publishers will be heard and have an opportunity to influence not only E-ATP's direction but EU policies.

Q: What will be your first goals as Chair of the European Division?

A: My initial goals will be to:

- 1. Seek, listen to, and engage with European Test Publishers.
- 2. Seek, listen to, and engage with organizations that service the needs of European Test Publishers.
- 3. Discuss, develop consensus, and then document the vision and mission statements of the E-ATP.



College Board VP, Wayne Camara, to lead ATP

Wayne J. Camara, Ph.D., Vice President for Research and Psychometrics at the College Board, will serve as 2007 Chair and President of the Association of Test Publishers. Prior to joining the College Board in 1994, Dr. Camara served as Assistant Executive Director of Science at the American Psychological Association (APA). While at APA, he directed governance and scientific involvement in policy and research activities concerning testing, and research funding and directed the revision of the *Standards for Educational and Psychological Testing*. Dr. Camara has assisted federal agencies in developing regulations (e.g., Civil Rights Act, ADA, Goals 2000, integrity testing) and has testified before Congress and state legislatures. His principal areas of research are standards and professional practice in testing, test validity, fairness, testing accommodations, and ethical issues in testing. Dr. Camara is a fellow of APA (Divisions 1, 5, 14), and past president of Division 5. He has also served on the National Council on Measurement in Education Board, the DoD TAC and is a member of the Pennsylvania State Assessment Program TAC.

ATP Elects New Directors to 2007 Board

ATP concluded its 2007 Board of Directors election this fall. Individuals elected to the Board were Betty Bergstrom, Ph.D., Vice President of Testing Services for Pearson VUE; John Fremer, Ph.D., President of Caveon Test Security; and Phil Young, Ph.D., Executive Director of Program Procurement for large scale assessment programs within the Elementary and Secondary Education Division (K-12) of the Educational Testing Service (ETS).

The new Board Members will each serve a two-year term and will take office at ATP's annual *Innovations in Testing* Conference scheduled for February 5-7, 2007 at the Westin Mission Hills Resort in Palm Springs, CA.

"The high caliber of individuals who ran for the Board, and the outstanding qualifications of those who were elected, are a tribute to the continuing mission of the Association," said ATP Chair Charlie Wonderlic, President of Wonderlic, Inc.

Dr. Philip Young began his assessment career in 1986 with The Psychological Corporation (Harcourt) and also worked for Riverside Publishing for three years before joining ETS in 2002. Prior to his assessment career Dr. Young taught graduate and undergraduate students in educational psychology at Towson University for fourteen years. Altogether, his teaching and business careers have spanned 37 years. He is currently Chair of the ATP Education Division and is also a member of AERA, NCME and the National Association of Test Directors (NATD). He is a frequent public speaker on assessment topics and has been active in following and helping influence legislative actions affecting assessment. Dr. Young earned his Ph.D. from Northwestern University in Evanston, Illinois.
